### 1.0 Call to Order

**4.1** Fishtail Beach Access: Sandra has met with property owners in the Fishtail Beach access area. Besides the poor condition of the access road/trail there is concern that any repairs or clearing of the area should not provide space and access to campers.

- Depletion of the Inlet prawn fishery; a proposal to shut down the commercial prawn fishery in the Inlet was discussed.
- Posting of G8 minutes on the website. For now only the agenda will be posted; further discussion re posting minutes is planned.
- East Porpoise Bay reps report that the gravel haul from the northern pit has been completed.
- The SHCA applications for funding for work projects and community improvement have been unsuccessful. (Recreational Task Force Funding). The committee found that these items had previously been submitted by SHCA, and that they could possibly be funded by the District Capital Works or Maintenance budgets.

- **7.3** Bob has written a "Welcoming" letter that will be sent to new members via e-mail as well as the hand written kit that is now being used.
- **7.4** The group involved with the protection of Block 350 has selected a name for their organisation. The "Hidden Grove Hikers" was picked in response to a tourism report.

### 8.0 New Business

- **8.1** There was a discussion about the possibility of having bus shelters throughout the Sandy Hook area for those children waiting for the school buses. It was noted that the pickup points are so widely scattered in small groups, that this would probably not be feasible. Julie Towle will review this and report to the next meeting..
- **8.2** It was decided that any items that we purchase be inventoried and an up to date list be kept by the treasurer and secretary.
- **8.3** Bob's report on "e-mail communication guidelines" was postponed to our next meeting because it was getting too late to introduce it tonight.
- **8.4** Ron Atkinson asked if anyone had noticed that right behind the Beaver Pond, roads were being put in and the area had been cleared. No-one knew of any project that was going on in there so he was to call the District to find out what is happening in that area.
