Minutes of Meeting

1. Call to Order

4. Ongoing Business

4.1 Website

Flavio provided an update on the Sandy Hook Community Association website:

 The website domain name <u>www.sandyhookca.com</u> expired and Flavio did not have access to renew the domain name. Instead, he purchased a new domain name www.sandyhookca.org and has a new generic email sandyhookca@gmail.com

- With the new .org domain name, everything is now under one service.
- Flavio originally thought everything (website and domain name) was hosted under one service. However, the domain name was hosted through another site and is registered and paid for by a former SHCA Board member. This board member is no longer living in Canada.
- There was concern that residents and members may not know the new website URL and contact email and may have the old information bookmarked.
- A decision was made by board members present to let 45 days pass so that the SHCA Board can re-purchase the old .com domain name. Once we have ownership of the .com, Flavio will set up an automatic redirect from the old URL to the new .org web address.
- The new service is \$60/year for both the Wordpress service and the domain name. This is the same rate as was previously paid.

4.2 Events - Meet & Greet

Action items to prepare for the event include:

- Kara to make poster and Kara/Jenny to post on bulletin boards
- Kara to make handouts for board to give to neighbours.
- Flavio to send out a reminder email.
- Someone will need to purchase wine before the event.

4.3 Community Centre/Space

Susan received one piece of feedback from a resident that was against the idea of a community space.

- A survey or poll may need to be conducted after the meet and greet to get a clear understanding of whether residents are for or against exploring this idea further.
